TABC UPDATES AND IMPORTANT DATES TO REMEMBER

Regarding Permit, Fee, and Technological Changes

- 1. For several months, TWGGA has been actively engaged with TABC and advocating for the Texas Wine Industry about the proposed permit and fee changes. TWGGA's recommendations have been formally presented to the TABC and can be found <u>here</u>.
- 2. TABC is accepting public comments through Monday August 2nd. You are strongly encouraged to provide your own feedback, recommendations, and opinions. The Texas Wine Industry's strength and continued efforts to grow is because the primary stakeholders are invested. Comments regarding the permit fee change should be directed to Shana Horton at <u>Shana.horton@tabc.texas.gov</u> Comments must be received by August 2, 2021. Once submitted they will receive a written response that will become part of the preamble record on the rule change.

 - d. September 1, 2021. TABC will launch the Alcohol Industry Management System (<u>AIMS</u>). This new online system will be used by businesses to apply for licenses* and other functions. Details can be found <u>here</u>

Caveat Regarding Permit and Fees for Temporary Public Event*

On August 1st, TABC will publish new forms to request authority to conduct a temporary event, including a winery festival.

As of this writing, for events that take place on or after September 1, only PRIVATE events will be eligible for file and use notice on <u>AIMS</u>. Public events, such as winery festivals, will require a temporary event authorization application and will get a certificate from TABC. Those applications must be filed more than 10 business days before the event starts to avoid late fees.

TWGGA has alerted TABC that this change will prevent wineries from using the file and use notification process for festivals. We understand that TABC is re-evaluating how to handle festival applications in the new system.

Until TABC announces a change in this regard, if you are planning to participate in a festival in September, use the new forms in August and apply for temporary event authorization more than 10 business days in advance to avoid late fees.

2021 LEGISLATIVE ACTIVITIES SUPPORTED AND FUNDED BY TWGGA TO PROMOTE AND PROTECT THE TEXAS WINE INDUSTRY

TWGGA Legislative Committee Wraps Up 86th Legislative Session

Upon entering this legislative session, TWGGA had three main goals:

- 1. Actively engage in developing language and passage of legislation representing the compromise reached on the labeling issue.
- 2. Repeal of the 35K gallon cap in current law for sales direct to consumer
- 3. Continuing to protect the privileges and abilities that holders of G permits currently enjoy.

TWGGA was successful on two of those three items.

- 1. The Governor signed HB 1957 which represents the label agreement reached by the various segments of the wine and grape growing industry.
- 2. We continue to be stymied in our efforts to repeal the 35K gallon cap.
- 3. Thankfully there was no legislation which passed that would negatively impact the wine or grape growing segments of our industry.

Of the over 250 alcohol related bills that TWGGA tracked during this past legislative session 14 bills passed both houses of the legislature. Of those, nine were have already been signed leaving five awaiting his signature, allowed to become law without his signature or vetoed.
